Mr Papadopoulos presented the critical point of the project which is the construction of Environmental Actors Training Field which has important delay because of the bad weather conditions in K. Nevrokopi during the winter. So, all project partners argued that it is necessary to be requested a three month time extension of the project from the Joint Secretariat in order the pilot operation of the training process to last an adequate time period. The solution that all concluded was to condense the duration of pilot operation of the training process.

After that, project partners discussed the deliverables that should be jointly implemented by project partners, the steps, actions and specifications that will be jointly followed by project partners in order to implement the common deliverables. More specifically, Mr Papadopoulos shared an excel file and a word file where he had collected all the necessary information for the implementation of the common deliverables 4.1.1 – 4.5.1 and 4.1.2 – 4.5.2, which include the certification framework and manual and training programmes and training material.

The Project manager of Association of Hunters and fishermen "Sokol" (PB5) mentioned that the tender procedure for the deliverable 5.5.3 (On the field pilot actions) was barren because the amount was to small to attract possible contractors. For this reason, PB5 will prepare and send to Hunting Federation of Macedonia and Thrace a modification request in order to decrease the physical item of the above deliverable.

Moreover, all project beneficiaries representatives discussed the content, issues, publicity needs and technical details of the communication activities and updated the time table for the implementation of information and publicity actions. The above table shows the start and end date of each deliverable of WP2.
